

Terms of Service for Dezinga

1. Introduction

Welcome to Dezinga, a Web3-based social gaming platform built on the Solana Network (SOL). By accessing our website, applications, and services, you agree to be bound by these Terms of Service (ToS), our Privacy Policy, and all applicable laws and regulations.

2. Eligibility
